

# LEAD<sup>™</sup> Program Terms and Conditions (Applicant)

These are the Terms and Conditions ("Terms") pursuant to which all EXCELEAS<sup>®</sup>, LLC ("EXCELEAS") subscribers and end users ("You") may use EXCELEAS' website and EXCELEAS' services (each as defined below). These Terms include EXCELEAS' Privacy Policy, which is incorporated into these Terms by reference and can be reviewed by visiting <u>www.exceleas.com/privacy-policy</u>.

These Terms are a binding agreement between You and EXCELEAS, the operator of this website in the state or country in which You reside, and You are deemed to accept these Terms each and every time You use or access EXCELEAS' website or use an EXCELEAS service (as defined in the paragraph below). If, after reading these Terms, you do not want to accept or abide by these Terms, you must not use this website or EXCELEAS' services.

EXCELEAS' Software as a Service (SaaS) website, known as the Law Enforcement Applicant Database ™ program ("LEAD"), is located at <u>www.leadprogram.us</u> (the "Site"). EXCELEAS' services (the "Services") mean the applications, materials, information, services, and documents offered by EXCELEAS, including LEAD. Users ("Users") may also access the Site to create individual profiles, which may include personal information ("Profiles"), and to make these Profiles, or aspects thereof, available to certain Users.

EXCELEAS may revise these Terms at any time by posting an updated version to this URL. Because these Terms bind You, You must visit this URL periodically to review the most current Terms. It is Your responsibility to review the most current Terms and Your failure to do so will not prevent You from being bound by these Terms.

Users must abide by these Terms. If any User violates these Terms, EXCELEAS may suspend or terminate the User's access to the Site or Services.

You must be 13 years of age or older to visit or use EXCELEAS' Site, and, if under the age of 18, You must use the Site under the supervision of a parent, legal guardian, or other responsible adult.

## 1. Your Use of EXCELEAS Information

Subject to these Terms, You may access and use the Site and EXCELEAS' Information to download and print a single copy of the content available on or from the Site solely for Your personal, non-commercial use. The contents of the Site, such as designs, text, graphics, images, video, information, logos, button icons, software, audio files and other EXCELEAS information (the "EXCELEAS Information"), are protected under copyright, trademark and other laws, and are the property of EXCELEAS or EXCELEAS' licensors. The organization and presentation of all Information of EXCELEAS and is protected by copyright, trademark, and other laws. Any use of EXCELEAS Information in contravention of these Terms may violate these laws and/or applicable communications regulations and statutes, and is prohibited. If You copy any EXCELEAS Information, you must preserve all copyright, trademark, service mark or any other proprietary notice provided in the EXCELEAS Information.

Any code that EXCELEAS creates to generate or display any EXCELEAS Information Content or the pages making up the Site are also protected by EXCELEAS' copyright and You may not copy or adapt or otherwise use such code. **EXCELEAS will use any and all legal means to protect its code.** 



You agree not to sell or modify the EXCELEAS Information or reproduce, display, publicly perform, distribute, or otherwise use the EXCELEAS Information in any way for any public or commercial purpose, in connection with products or services that are not those of the Site, in any other manner that is likely to cause confusion, disparages or discredits EXCELEAS or its licensors, dilutes the strength of EXCELEAS' or its licensor's property, or otherwise infringes EXCELEAS' or its licensor's intellectual property rights. You shall not misuse the EXCELEAS Information or otherwise use the EXCELEAS Information in any way that violates any applicable law or regulation.

# 2. Your Use of EXCELEAS' Services

You must maintain the confidentiality of Your account, Profile and passwords, as applicable. You shall not share Your password or other account access information with any other party, temporarily or permanently, and You shall be responsible for all uses and end users of EXCELEAS Site registrations and passwords, whether or not authorized by You. You shall immediately notify EXCELEAS of any unauthorized use of Your account, Profile, or passwords.

All EXCELEAS Users shall not:

- a. transmit, post, distribute, store or destroy material, including without limitation EXCELEAS Information, in violation of any applicable law or regulation, including but not limited to: laws or regulations governing the collection, processing, or transfer of personal information, or in breach of EXCELEAS' privacy policy;
- b. use any device to navigate or search any the Site other than the tools available on the Site, generally available third-party web browsers, or other tools approved by EXCELEAS in advance and in writing;
- c. use any data mining, robots or similar data gathering or extraction methods;
- violate or attempt to violate the security of the Site including attempting to probe, scan or test the vulnerability of a system or network or to breach security or authentication measures without proper authorization;
- e. forge any TCP/IP packet header or any part of the header information in any e-mail or newsgroup posting;
- f. reverse engineer or decompile any parts of the Site;
- g. aggregate, copy or duplicate in any manner any of the EXCELEAS Information available from the Site, including expired job ads, other than as permitted by these Terms;
- h. frame or link to any EXCELEAS Information available from the Site, unless permitted by these Terms;
- post any content or material that promotes or endorses false or misleading information or illegal activities, or endorses or provides instructional information about illegal activities or other activities prohibited by these Terms, such as making or buying illegal weapons, violating someone's privacy, providing or creating computer viruses or pirating media;
- j. post any resume or Profile or apply for any job on behalf of another party;



- k. share with a third party any login credentials to the Site;
- I. access data not intended for You or logging into a server or account which You are not authorized to access;
- m. post or submit to the Site any incomplete, false or inaccurate biographical information or information that is not Your own or information You are not authorized to post or submit;
- n. solicit passwords or personally identifiable information from other Users;
- o. leave Your password available for another person to view;
- p. leave Your account to the Site logged in at an unattended and unlocked device;
- q. use any device that is infected with a virus or does not contain adequate virus protection to access the Site;
- r. delete or alter any material posted by any other person or entity;
- s. harass, incite harassment or advocate harassment of any group, company, or individual;
- t. promote or endorse an illegal or unauthorized copy of another person's copyrighted work, such by as providing or making available pirated computer programs or links to them, providing or making available information to circumvent manufacture-installed copy-protect devices, or providing or making available pirated music or other media or links to pirated music or other media files; or
- u. use EXCELEAS' Services for any unlawful purpose or any illegal activity, or post or submit any content, resume, or job ad that is defamatory, libelous, implicitly or explicitly offensive, vulgar, obscene, threatening, abusive, hateful, racist, discriminatory, of a menacing character or likely to cause annoyance, inconvenience, embarrassment, anxiety or could cause harassment to any person or include any links to pornographic, indecent or sexually explicit material of any kind, as determined by EXCELEAS' unfettered discretion.

Violations of system or network security may result in civil and/or criminal liability. EXCELEAS will investigate occurrences that may involve such violations and may cooperate with law enforcement authorities in prosecuting Users who are involved in these violations.

## 3. Additional Terms Applicable to Applicants and Other End Users

You must register an account with the Site in order to apply for employment with a law enforcement agency ("Agency"), or You will not be permitted to apply with that Agency. To register on the Site, You agree that You are at least 18 years of age and that You are legally entitled to work in the United States.



When You register on the Site, You will be asked to create an account and provide EXCELEAS with certain information, including Personal Information, such as, Your full name, date of birth, the last four digits of your social security number, zip code, valid email address, phone number, and other information necessary to establish your account ("Personal Information"). If You legally change your name, You must update Your user profile on the Site to reflect the change.

When supplying Personal Information, You will be asked to supply certain demographic information, specifically your gender and race/ethnicity. Supplying demographic information is completely voluntary and You are not required to do so. Should You decline to supply gender or race/ethnicity information, it will not harm Your chances of employment with any law enforcement agency using the Site. If You choose to provide your gender and race/ethnicity information, that data will remain confidential, be anonymized so it does not identify you, and will not be viewed in conjunction with Your other Personal Information by anyone, including any Agency You register with. However, that data may be used for required periodic government reporting to the US Equal Employment Opportunity Commission, or for other mandated compliance reporting by an Agency, such as to meet the Agency's accreditation requirements. Also, EXCLEAS will use that data to assist with the Site's *Statistical Tracking of Applicant Trends (STAT*<sup>TM</sup>) tool, which may be used by Agencies to assist in their recruitment efforts, and to analyze other recruitment trends throughout the United States.

Any Personal Information You submit must be accurate and describe You, an individual person, identically as depicted on Your lawfully issued, current, and valid state driver's license or US Passport. Your profile requires standard fields to be completed and you may not include in these fields any telephone numbers, street addresses, or other means of contacting You, other than Your name.

Personal Information You submit must be identical to the information supplied in any hiring document or form used by a law enforcement agency You register with on the Site, including any online application for employment You complete on the Site. You acknowledge that Your failure to supply accurate Personal Information may result in being disqualified by the law enforcement agency You register with.

You acknowledge that the Site does not, and will not, store or provide any negative information possibly associated with Your experience in the hiring process with any Agency using the Site, including but not limited to: failing written or physical agility testing, failing a polygraph or computer voice-stress analysis test, failing a background investigation, or being terminated from employment.

You agree that registering with an Agency on the Site and being "Offered Employment" by an Agency using the Site are, in and of themselves, indisputable facts that do not adversely affect Your reputation in any way.

The email address You supply must be valid and the best point of contact for You. It will be used by the Site to send all registration confirmation notices and any job advertisement notifications You opt to receive. It is Your responsibility to ensure the email address You supply the Site is correct (during the initial registration and any future changes). If You change Your email address, You must update the Site with Your new email address. Failure to update Your email address may result in missed registration confirmation notices and job advertisement notifications (if selected).

You acknowledge and agree that You are solely responsible for the form, content and accuracy of any application information provided by You on the Site.



You have no ownership rights in Your account and if You cancel Your account or Your account is terminated, all Your account information from EXCELEAS, including application information, profiles, cover letters, saved jobs, questionnaires may be marked as deleted in and may be deleted from EXCELEAS' databases and removed from the Site. Information may continue to be available for some period of time because of delays in propagating such deletion through EXCELEAS' web servers. In addition, third parties may retain saved copies of Your Information.

# 4. User Responsibilities When Using Certain Features of the Site

## Registering with Agencies on the Site

To apply with an Agency, You must first register with the Agency using the Site's Agency registration section. You cannot participate in the Agency's hiring process without registering with that Agency. You shall only register with Agency with whom you intend to seek employment.

You must register prior to the deadline in Agency's registration period, which is specified in the Agency's job advertisement posted in the Careers section of the Site, or in outside hiring notices used by the Agency. All deadlines expire at 23:59:59 hours (EST) on the date listed. No registration will be accepted by the Site past the Agency's deadline. If You are uncertain of the registration deadline, it is Your responsibility to contact the Agency for this information.

Upon successfully registering with an Agency, You must retain Your registration confirmation notice sent to Your email address by the Site. Do not delete this record until all phases of the Agency's hiring process have concluded. You may be required to present your registration confirmation notice, along with valid government issued identification, to personnel representing the Agency you registered with, in order to verify attendance at any hiring functions conducted by the Agency, such as written testing, physical agility testing, an oral interview board, a polygraph/CVSA examination, etc. Your registration confirmation notice can be printed and displayed in paper format, or it can be displayed on Your mobile device screen. To display it electronically, You must be certain it has been saved to the device, or that internet access will be available at the location You're attending.

You acknowledge that any Agency You registered with will have access to view other participating Agencies You have registered with on the Site, including the date You registered, and if You were "Offered Employment" by any of those Agencies. Your registration history with any Agency on the Site is permanent, even if the Agency no longer has an active account on the Site. A registration record may be removed by EXCELEAS for just cause (e.g., account hacked, accidental registration with agency applicant did not intend to apply with, etc.), after consultation with the Agency registered with.

Use of the Site's Online Job Applications/Forms

When using the Site's online job application feature, You must complete and submit the Agency's job application prior to the deadline listed in Your dashboard. The deadline expires on the listed date at 23:59:59 hours (EST). If You fail to complete and submit the job application prior to the deadline, the Agency may remove You from further consideration from its hiring process.



You are required to complete all online job applications or forms accurately and truthfully. You agree that You will not omit, falsify, or otherwise misrepresent information You provide on any electronic document used to determine Your suitability for employment with an Agency. If an Agency discovers that You omitted, falsified, or otherwise misrepresented information You submitted on the Site, You acknowledge that the Agency may remove You from further consideration from its hiring process.

## User Profile Visibility Settings

You control Your Profile visibility settings and can allow all Agencies, regardless of Your registration status with them, to view certain features of Your Profile for recruitment purposes, excluding Your gender and race/ethnicity information, if You supplied this information. You are not required to make Your Profile visible to Agencies you have not registered with. This option is voluntary and You can change Your visibility settings at any time.

If You opt to make Your Profile visible, Your name may appear in an Agency's search results. The email address and phone number You provided on the Site will be visible to Agencies. You agree that Agencies can use Your email address and phone number to contact You for recruitment purposes.

When Your Profile is visible, an Agency will be able to view all Agencies You have registered with on the Site, including the date You registered with them, and if You have been "Offered Employment" by them.

The Site allows You to upload a cover letter and resume to Your Profile, but is not required. If You upload a cover letter or resume, You agree to allow Agencies to view these documents when Your Profile is visible and consent to the Agency's collection and lawful use of Your Personal Information contained in Your resume.

## Use of the Site's Payment Processing Features

Certain Agencies that You may decide to register with on the Site assess their own application testing fee as a requirement to participate in their hiring process. If You intend to register with an Agency that assesses a fee, and that Agency has authorized EXCELEAS to collect said fee, You agree that You will pay the required fee during the registration process on the Site. EXCELEAS will collect the fee on the Site and remit it to the Agency You are registering with. If You fail to pay the required fee during registration, You acknowledge that the Agency may remove You from further consideration from its hiring process.

EXCELEAS has chosen PayPal® as the Site's payment gateway tool. When submitting a payment, You agree to use PayPal's service to collect fees assessed by the Agency you are registering with. You must also agree to PayPal's Terms when using their application. Once a payment has been processed, You will receive an emailed receipt from PayPal, which You are encouraged to store in Your records. Once a payment is received, You cannot seek a refund from EXCELEAS. Any request for a refund, partial or whole, must be made with the Agency You registered with and, at the Agency's discretion, You acknowledge that such request may or may not be honored.

Recognizing that certain applicants may not have the financial resources to pay application testing fees, an Agency may authorize an exemption for candidates prone to financial hardship. EXCELEAS has no involvement with an Agency's decision to waive their fee, or the criteria used to determine any waiver. If an Agency opts to waive fees for candidates claiming financial hardship, You can select the option to claim financial hardship when registering with the Agency. In order to claim financial hardship, You must meet the Agency's requirements to do so. An Agency may also request that You supply proof of Your financial hardship status to determine if it meets their requirements. If You



cannot prove your financial hardship status, as specified by the Agency You are registering with, You acknowledge that the Agency may remove You from further consideration from its hiring process.

#### Job Advertisement Email Notices

Users on the Site can choose to receive job advertisement notifications, sent to the email address in the User's Profile. These notifications alert the User to job advertisements posted by an Agency in the Careers section of the Site. You can choose to receive job advertisement notifications by adjusting the settings in Your Profile on the Site. You must select a distance from Your zip code in which You want to receive job advertisement notifications from Agencies. You can adjust these settings at any time. If You no longer want to receive job advertisement notifications, You can "opt-out" by changing the settings in Your Profile.

## 5. User Content and Submissions

All information, data, text, photographs, graphics, video, messages or other materials submitted, posted or displayed by You on or through the Site ("User Content") is the sole responsibility of the person from which such User Content originated. EXCELEAS claims no ownership or control over any User Content. You or a third-party licensor, as appropriate, retain all patent, trademark and copyright to any User Content you submit, post or display on or through the Site and You are responsible for protecting those rights, as necessary. By submitting, posting or displaying User Content on or through the Site, you grant EXCELEAS a worldwide, non-exclusive, royalty-free, transferable, sub-licensable license to use, reproduce, adapt, distribute and publish such User Content through the Site. Additionally, by submitting, posting or displaying User Content which is intended to be available to the other Users, you grant EXCELEAS a worldwide, non-exclusive, adapt, distribute and publish such User Content through the Site. Additionally, by submitting, posting or displaying User Content which is intended to be available to the other Users, you grant EXCELEAS a worldwide, non-exclusive, royalty-free license to reproduce, adapt, distribute and publish such User Content for the purpose of promoting EXCELEAS and its Services. EXCELEAS shall discontinue this licensed use within a commercially reasonable period after such User Content is removed from the Site. EXCELEAS may refuse to accept, post, display or transmit any User Content in its sole discretion.

You also represent and warrant that You have the right to grant, or that the holder of any rights, including moral rights in such content has completely and effectively waived all such rights and validly and irrevocably granted to You the right to grant, the license stated above. If You post User Content in any public area of the Site, You also permit any User to access, display, view, store and reproduce such User Content for any lawful purpose, including its commercial use. Subject to the foregoing, the owner of such User Content placed on the Site retains any and all rights that may exist in such User Content. EXCELEAS may review and remove any User Content that, in its sole judgment, violates these Terms, violates applicable laws, rules or regulations, is abusive, disruptive, offensive or illegal, or violates the rights of, or harms or threatens the safety of, Users of the Site. EXCELEAS may expel Users and prevent their further access to the Site and/or use of EXCELEAS' Services for violating the Terms or applicable laws, rules or regulations. EXCELEAS may take any action with respect to User Content that it deems necessary, useful or appropriate in its sole discretion if it believes that such User Content could create liability for EXCELEAS, damage EXCELEAS' brand or image, or cause EXCELEAS to lose Users or (in whole or in part) the services of its ISPs or other suppliers.



EXCELEAS does not guarantee the truthfulness, accuracy, or reliability of User Content, derivative works from User Content, or any other communications posted by Users, nor does EXCELEAS endorse any opinions expressed by Users. You acknowledge that any reliance on material posted by other Users will be at Your own risk.

The following is a partial list of User Content that is prohibited by EXCELEAS on the Site. The list below is for illustration only and is not a complete list of all prohibited User Content.

#### Content that:

- promotes or endorses an illegal or unauthorized copy of another person's copyrighted work, such as
  providing or making available pirated computer programs or links to them, providing or making available
  information to circumvent manufacture-installed copy-protect devices, or providing or making available
  pirated music or other media or links to pirated music or other media files;
- contains restricted or password only access pages, or hidden pages or images;
- displays or links to pornographic, indecent or sexually explicit material of any kind;
- provides or links to material that exploits people under the age of 18 in a sexual, violent or other manner, or solicits personal information from anyone under 18; or
- provides instructional information about illegal activities or other activities prohibited by these Terms, including without limitation, making or buying illegal weapons, violating someone's privacy, providing or creating computer viruses or pirating any media; and
- solicits passwords or personal identifying information from other Users.

Any Profile You submit must describe You, an individual person. Examples of inappropriate and prohibited Profiles include, but are not limited to, Profiles that purport to represent an animal, place, inanimate object, fictional character, or real individual that is not You.



# 6. <u>Policy Regarding Termination of Users Who Infringe the Copyright or Other Intellectual Property</u> <u>Rights of Others</u>

EXCELEAS respects the intellectual property of others, and we ask our Users and content partners to do the same. The unauthorized posting, reproduction, copying, distribution, modification, public display or public performance of copyrighted works constitutes infringement of the copyright owners' rights. As a condition to Your use of the Site, You agree not to use the Site to infringe the intellectual property rights of others in any way. EXCELEAS may terminate the accounts of any Users, and block access to the Site of any Users who are repeat infringers of the copyrights, or other intellectual property rights, of others. EXCELEAS may, in its sole discretion, take these actions to limit access to the Site and/or terminate the accounts at any time, in our sole discretion, Users who infringe any intellectual property rights of others, whether or not there is any repeat infringement, with or without notice, and without any liability to the User who is terminated or to the User whose access is blocked. ## 7. EXCELEAS' Liability
